ORDINANCE NO. 16-s.2024

AN ORDINANCE APPROPRIATING AN AMOUNT OF ONE HUNDRED SEVENTY-FIVE MILLION FIVE HUNDRED SIXTY-FIVE THOUSAND ONE HUNDRED SEVENTEEN PESOS (P175,565,117.00) FOR THE ANNUAL BUDGET OF THE GENERAL FUND AND TWENTY-THREE MILLION FOUR HUNDRED SIXTY THOUSAND PESOS (P23,460,000.00) FOR THE CALAMBA WATER SYSTEM OF THE MUNICIPALITY OF CALAMBA, MISAMIS OCCIDENTAL FOR THE CALENDAR YEAR 2025.

Be it ordained by the Sangguniang Bayan of Calamba, Misamis Occidental in its Regular Session assembled that:

SECTION 1. TITLE: This Ordinance shall be known as "**AN ORDINANCE APPROPRIATING AN AMOUNT OF ONE HUNDRED SEVENTY-FIVE MILLION FIVE HUNDRED SIXTY-FIVE THOUSAND ONE HUNDRED SEVENTEEN PESOS (P175,565,117.00) FOR THE ANNUAL BUDGET OF THE GENERAL FUND AND TWENTY-THREE MILLION FOUR HUNDRED SIXTY THOUSAND PESOS (P23,460,000.00) FOR THE CALAMBA WATER SYSTEM OF THE MUNICIPALITY OF CALAMBA, MISAMIS OCCIDENTAL FOR THE CALENDAR YEAR 2025.**"

SECTION 2. SOURCE OF FUND FOR THE GENERAL FUND. The source of fund for the General Fund in the amount of One Hundred Seventy-Five Thousand Five Hundred Sixty-Five Thousand One Hundred Seventeen Pesos (P175,565,117.00) is coming from the National Tax Allocation

SECTION 3. SOURCE OF FUND FOR THE CALAMBA WATER SYSTEM. The Source of fund in the amount of Twenty-Three Million Four Hundred Sixty Thousand Pesos (P23,460,000.00) for the Calamba Water System is coming from the Revenue of their Operations.


Section 4. EFFECTIVITY. This Ordinance shall take effect January 1, 2025.
