WHEREAS, Republic Act 10121 also known as the Philippine Disaster Risk Reduction and Management Act of 2010, an act strengthening the Philippine Disaster Risk Reduction and Management System, provides the legal basis for polices, plans, programs to deal with disasters;

WHEREAS, the Municipal DRRM is in consonance with the National Disaster Risk Reduction and Management Plan which covers the four thematic areas; namely disaster prevention mitigation, disaster preparedness, disaster response, disaster recovery and rehabilitation;

WHEREAS, Municipal DRRM is consistent with the National Disaster Rick Reduction and Management Framework and with the Regional and Provincial DRRM Plans;

WHEREAS, on motion of Hon. Joseph C. Malayao and duly seconded by all the members present;

NOW THEREFORE ON JOINT SPONSORSHIP, Be it resolved by the Sangguniang Bayan of Calamba, Misamis Occidental as it is hereby resolved to adopt the Municipal Contingency Plan for Landslide, Flood and Fire Hazards (CP) for the Municipality of Calamba, Misamis Occidental.
