- 1. Execute/sign all documents necessary to subscribe to LBP's "weAccess";
- Designate/authorize personnel to act as "maker" or "authorizer" for the company's access to LBP's weAcess banking facility; and
- Amend/add/delete enrolled deposit account/s as source and/or destination account/s, access rights to the weAccess modules, authorization rules and/or any information on the original and succeeding enrollments.

And that the same is hereby confirmed and ratified;
