RESOLUTION NO. 109-s.2020

RESOLUTION ADOPTING THE COMPREHENSIVE DEVELOPMENT PLAN (CDP) AND THE LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) FOR CALENDAR YEAR 2020-2025.

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991, mandated that there shall be a Comprehensive Multi-Sectoral Plan and the Annual Investment Plan to assist in setting the direction of economic and social development in the municipality;

WHEREAS, per section 9 paragraph (a) of Republic Act No. 9729 otherwise known as Climate Change Act of 2009 and Republic Act No. 10121, known as the Philippine Disaster Risk Reduction and Management Act of 2010 also mandates the mainstreaming and ensuring that the Comprehensive Development Plan (CDP) shall be a climate change and disaster risk resilient;

WHEREAS, the LGU of Calamba headed by the Municipal Mayor together with the Sangguniang Bayan headed by the Municipal Vice Mayor and the CSO and with the technical assistance provided by the Department of the Interior and Local Government (DILG) conducted a seminar workshop/writeshop followed by a simultaneous sectoral committee workshop for the formulation and updating the Comprehensive Development Plan and the Local Development Investment Plan Program for Calendar Year 2020-2025;

WHEREAS, the Comprehensive Development Plan and the Local Development Investment Program for Calendar Year 2020-2025 presented and discussed in the meeting of the Municipal Development Council and that the development programs, projects, and activities stipulated in the CDP and LDIP for 2020-2025 are geared towards economic, social, cultural, infrastructure and facilities which are the real felt needs of the populace to improve/uplift their standard of living.

WHEREAS, on motion of Hon. Emmanuel M. Cale and duly seconded by all the members present;

NOW THEREFORE ON JOINT SPONSORSHIP, Be it resolved by the Sangguniang Bayan of Calamba, Misamis Occidental as it is hereby resolved to adopt the Comprehensive Development Plan (CDP) and the Local Development Investment Program (LDIP) for Calendar Year 2020-2025.
