RESOLUTION NO. 106-s.2019

RESOLUTION PROHIBITING ANY EXTENSION OF STRUCTURE, ILLEGAL PARKING AND ANY OBSTRUCTION IN THE ROAD RIGHT OF WAY TO ANY MUNICIPAL ROAD, SIDEWALKS, ALLEYS AND NATIONAL ROAD WITHIN THE MUNICIPALITY OF CALAMBA, MISAMIS OCCIDENTAL

WHEREAS, Memorandum Circular No. 2019-121, dated 29th of July 2019 of the Department of the Interior and Local Government thru Secretary Eduardo M. Año, mandating all Local Government Units to clear roads of illegal structures and constructions within the area of responsibility;

WHEREAS, all existing structures temporary and permanent in nature declared as road right of way shall be demolished;

WHEREAS, all extension of any establishment, illegal parking of any type of vehicle private and government and obstruction in a declared road right of way, alleys, sidewalks shall be demolished, removed and vacated;

WHEREAS, the Local Chief Executive may revoke permits that give authority to private entities to occupy public roads, alleys and sidewalks;

WHEREAS, in case of non-compliance, appropriate administrative cases shall be filed pursuant to Section 60(c) of the Local Government Code of 1991 and other existing laws and policies;

WHEREAS, the Chief Executive also impose corresponding sanctions to the Local Officials and Employees against non-supportive and/or non-compliance of the said memorandum;


WHEREAS, on motion of Hon. Rodrigo T. Garcia and duly seconded by all the members present;

NOW THEREFORE ON JOINT SPONSORSHIP, Be it resolved by the Sangguniang Bayan of Calamba, Misamis Occidental as it is hereby resolved to prohibit any extension of structure, illegal parking and any obstruction in the road right of way to any municipal road, sidewalks, alleys and national road within the municipality of Calamba, Misamis Occidental

RESOLVED FINALLY to furnish copy of this resolution to Mr. Ben Cabasag, Team Leader, LGU Traffic Enforcer for information, guidance and appropriate action.
